◆Right to appeal to supervisory authority

Pursuant to Article13, (2) , (g)

In a case you wish to file a complaint about the processing of your personal data or about the way in which we have dealt with your complaint,you have the right to a complaint with the Personal Data Protection Commission and the Data Protection

Officer (if such is available).

You can file a complaint in one of the following ways:

1. **Personally** on paper form in the registry of CPDP of Address : Sofia 1592, Prof. Tsvetan Lazarov Blvd. № 2
2. **By Letter** to Address: Sofia 1592, Prof. Tsvetan Lazarov Blvd. № 2, Commission of Personal Data Protection.
3. **By Fax** to Address: 029153525.
4. **Via Electronic Means** to CPDP's e-mail Address (kzld@cpdp.bg). In that case,your complaint must be formatted as an electronic document,signed with an electronic signature (not scanned)

Trough the CPDP's Website <https://cpdp.bg/?p=pages&aid=6> by the way,described on the page.In this case,your complaint must be formatted as an electronic document,signed with an electronic signature.In each of these cases,the complaint should contain :

- **Complainant's data – Names, Address, Phone number, e-mail Address (if there's such)**
- **The nature of the complaint**
- **Other information and documents you consider relevant to the complaint**
- **Date and signature (for electronic documents - electronic,for paper documents - manual)**

CPDP provides a complaint form to the Commission (to assist and guide citizens) about the misuse of processing Personal Data in voter lists,supporting the registration of political subjects.The form can be downloaded from the following page :
